

About The Del Mar Foundation

As Del Mar's oldest 501(c)(3) non-profit, the Del Mar Foundation – with the generous support of its donors and dedicated volunteers – provides programs, makes grants and manages over \$2 million in endowment funds which benefit the community and the San Dieguito Lagoon. The community endowment provides long-term funding stability for community needs.

While best known for our Summer Twilight Concerts, First Thursdays cultural arts series, and numerous children's events, the Foundation funds and manages a wide array of community programs. In 2013, we launched DMF Talks, a free speakers series offering broadly-themed, world class presentations.

The Foundation also provides financial support in the form of grants to community organizations including, among others, Del Mar Community Connections, San Dieguito River Valley Conservancy, Del Mar Historical Society, and projects including the Del Mar Library Mosaic Wall and the Wounded Warriors program through the Del Mar Lifeguards. Over the years, the Foundation has served as an incubator or fiscal sponsor for many of the present day non-profits that so greatly enrich our community.

The mission of the Del Mar Foundation is to promote civic pride and cohesiveness, acquire and preserve open space, improve beaches and parklands, raise and grant funds, and sponsor diverse cultural programs and community events in Del Mar.

Dear Friends and Neighbors,

Thank you for your wholehearted commitment to the Del Mar Foundation, both in 2014 and throughout the 33 years of our existence. The following pages of the 2014 Annual Report are tangible proof that your contributions of both time and money resulted in this year being our most successful one ever.

The Foundation presented programs that ***inspired, informed and included*** over 22,000 attendees. We granted over \$40,000 throughout the community to worthwhile causes. Our programs ranged from Summer Twilight Concerts rocking us away at Powerhouse Park; children's events including the Easter Egg Hunt, 4th of July parade, and beach bonfire; DMF Talks featuring prize-winning scientists and their latest findings; and Cultural Arts concerts presenting world-renowned musicians performing in our community. The Foundation has a plan in place for the future and is moving strategically to fulfill it. Karen Wilson, our Executive Director, is implementing an Annual Giving Program that will make us stronger financially to cover the day-to-day operations of the Foundation and enhance our ability to grow our endowment. Our endowment goal is \$2,000,000 by 2020. With your help we can reach that goal, providing the financial strength necessary to double the amount of the Foundation's annual grants to the community and the sustainability to invest in our community long term.

Again, I want to thank you and the community for your continued support. The Del Mar area is a wonderful place to live and raise a family. The goal of the Foundation is to enhance that experience and make Del Mar an even better place to live.

GRANTS 2014

A big part of Del Mar's magic is created by people who work behind the scenes, and often unacknowledged, for Del Mar nonprofits. In 2014, the Del Mar Foundation was pleased to provide grants supporting the following organizations and individuals who are making a difference in our community.

The Del Mar Foundation, with the help of two generous donors, funded two additional state-of-the-art beach accessible wheelchairs. These chairs enable participants of the **Wounded Warriors program** and those with physical limitations to enjoy the beach and ocean.



The **Del Mar Historical Society** developed "Del Mar Voices," an audio history of this great town. The Del Mar Foundation granted funding to support this project.



Del Mar Community Connections received a grant to help support its popular Tuesday Lunch Connection program enabling otherwise homebound seniors to connect with others over a healthy meal at the Del Mar Community Building. The program includes speakers and music and serves about 400 seniors annually.



A grant to our **Del Mar Lifeguards** enabled the purchase of a set of scuba equipment for its search and rescue dive team.



The **San Dieguito River Valley Conservancy** approached the Del Mar Foundation for funding to support its architecturally stunning **Birdwing Open Air Classroom**, a place for young and old alike to learn about and appreciate the importance of our unique lagoon environment. This space serves upwards of 100,000 people annually.

The Del Mar Foundation granted over \$40,000 in 2014.

EVENTS 2014



Young Del Mar launched its new year and its new direction of serving children, families and parents by hosting its first ever **Parents' Night Out** at Hotel Indigo. Nearly 70 moms, dads and grandparents

enjoyed an evening of connecting with friends and neighbors over a glass of wine. Del Mar Foundation **playgroups** continue to provide a weekly opportunity for infants and toddlers to get out of the house with mom and/or dad, and a place where support is provided and friendships are forged. The Young Del Mar committee organized its **Annual Easter Egg Hunt** with Easter bunny Kim Filanc in the starring role. Seagrove Park transformed into an Easter Egg paradise with 6,000 "hidden" eggs. On July 4th, Del Mar once again became a river of red, white and blue as families and friends took to the street in a colorful **4th of July parade** and celebration. The **Spooktacular Beach Bonfire** lit up our October



sky for over 400 kids who enjoyed the blazing fires, storytelling, and delicious S'Mores. Young Del Mar ended the year with the launch of its 3-part **Speaker's Series** on parenting, a partnership with **Del Mar Hills Academy** and **Del Mar Heights Elementary School**.



The first presentation took place at the Powerhouse and featured **Dr. Lee Hausner**, a best-selling author and advisor to families of wealth on raising responsible, community-oriented and well-balanced children.



Cultural Arts Committee provided another year of sold out **Bluegrass & Beyond** concerts, along with its subscription-based and highly popular **First Thursdays** season. Highlights of the year included The Claire Lynch Band, The Barefoot Movement, and Charles McPherson. The wine & cheese reception, a First Thursdays tradition, preceded the concerts and brought together Del Marians on the Powerhouse patio for a chance to relax, meet new people, and catch up with old friends.



The **Summer Twilight Concerts** attracted thousands of participants who rocked the summer in perfect beach style. With a total estimated attendance of 15,000 concert-goers, the Del Mar Foundation increased the number of concerts from four to five. Bands included The Mighty Untouchables, Back to the Garden with Eve Selis, The Heroes, Haute




Chile and local band Sully and the Blue-Eyed Soul Band. The cost of the concerts was partially underwritten by individual benefactors who received "front row" seating at the concerts for the purchase of a

special limited edition concert blanket. Corporate sponsors included **Jakes Del Mar, Jelley Properties, Lutz Insurance, Pacifica Del Mar, Poseidon, Zel's Del Mar, Del Mar Thoroughbred Club**, along with a \$10,000 county grant made possible by the office of **County Supervisor Dave Roberts**.

Special guest speaker, Helen Thayer, was invited to Del Mar in collaboration with the **San Dieguito River Valley Conservancy** and was welcomed at an honorary luncheon at the home of Ira and Rose Ann Sharp. Dr. Fenical's presentation birthed a new "salon series" of intimate



gatherings in partnership with Scripps, including one-on-one conversations with researchers and personal tours of their labs.

Meet & Greets brought out neighbors and friends for casual get-togethers over a glass of wine and appetizers. In March, **Poseidon** hosted a gathering on its ocean front patio and in May **Pacifica Del Mar** welcomed guests in its restaurant bar.



Our **Summer Resident Book Club**, entitled "Three Books, Three Months, Three Meetings," was offered in collaboration with the **Del Mar Public Library**. It inspired participants to read

and discuss three highly acclaimed books as a group at Saturday morning gatherings hosted by Del Mar Foundation Board members.

At the close of summer, the Foundation joined forces with **Rotary Del Mar** to keep our beaches clean by inspiring dozens of civic-minded volunteers to pick up trash from our beaches, cliffs and streets.



At the Del Mar Foundation's second annual **Halloween Dog Parade**, owners and pets alike had a romping good time despite fierce canine costume competition. Nearly 50 dogs paraded for judges Terry Sinnott, Pat Vergne and Sherryl Parks in each of nine costume categories, including "Most Glamorous" and "Best Try."

The Del Mar Foundation placed a new plaque in our community this year: Located at the steps of the Del Mar Library, the plaque recognizes the contributions of major donors who helped finance the restoration of our iconic **Mosaic Wall**, as well as the outstanding work of artist Betsy Schulz and volunteer coordinator Pat Welsh.



As a tribute to our dedicated volunteers and generous donors, the Del Mar Foundation held its second **Celebrate Community** event. On a hot September afternoon, more than 50 guests enjoyed an El Pollo lunch and cool drinks in the shade of the Powerhouse patio ramada. In true community style, guests sang "Happy Birthday" and enjoyed birthday cake for three birthday celebrants.

Finally, the Del Mar Foundation continues to successfully grow and manage the community endowment, established in 2007 and now over \$1 million, as well as to provide financial management of the Lagoon Endowment and the Alvarado House Fund. With about \$2 million in total managed funds, the Del Mar Foundation fulfills a valuable and unique role in the community.

DMF 2014 Annual Report-Financial Statement Comments

The following financial statements are excerpts from the 2014 Financial Statements that were compiled by the certified public accounting firm of Friedman Brannen LLP. A complete copy of this compiled report is available from the Del Mar Foundation office upon request.

Statement of Activities

In 2014 the Foundation raised \$188,768 in donations. The Foundation received \$90,775 in program income, which includes ticket sales, grants and sponsorships for the various community programs it produced. These programs include the Twilight Concerts, the Cultural Arts events, and the children's programs. Expenses of \$62,653 were incurred in producing these programs, resulting in a surplus of \$28,122 from these activities.

The Foundation awarded \$41,808 in grants to support community activities and projects. Grants were made to help fund the shade structure for the San Dieguito River Valley's Birdwing Open Air Classroom, to purchase beach accessible wheelchairs for the Wounded Warriors Program through the Del Mar Lifeguard Association, to help fund the Del Mar Community Connections' Tuesday Lunch Connection program for seniors, to underwrite the costs of the Del Mar Historical Society's production of "Del Mar Voices," an audio history of Del Mar, and to purchase a set of scuba equipment for the Del Mar Lifeguards search and rescue dive team.

The Del Mar Foundation identifies and develops new grant ideas on a continuous basis with the support of its donors and volunteers.

Management, General and Fundraising expenses totaled \$113,774. These expenses were incurred to fundraise and sustain operations, and for general administrative activities, including support for our programs.

Statement of Financial Position (Balance Sheet) and Net Asset Analysis

The net assets of the Foundation as of 12/31/13 amounted to \$2,290,442 of which \$740,125 were in Operating Funds and Reserves, all of which can ultimately be used for the payment of operating expenses or grants. This operating fund net asset balance includes \$128,750 in pledges receivable, meaning that the funds have been pledged, but the pledge payment has not yet been received. As these pledges are paid, these funds will become unrestricted.

The Community Endowment, which is the endowment to be used for the support of the Foundation's expenses and grants, had net assets of \$1,043,901 on 12/31/14. Unrestricted net assets in this endowment fund amounted to \$330,653. Permanently Restricted net assets totaled \$713,248, of which \$642,500 was from contributions that have been received and invested, and \$25,250 was from pledges receivable and \$28,500 was pledges written off as uncollectible.

On 12/31/14 the Lagoon Endowment had net assets of \$699,817, all of which are Temporarily Restricted. This fund is overseen by the Foundation for the future benefit of the San Dieguito Lagoon maintenance. These funds were provided to the Foundation by the San Dieguito River Park Joint Powers Authority.

As of 2013, the Del Mar Foundation is managing the funds of the Del Mar Historical Society's Alvarado House Fund with assets of \$63,449 on 12/31/14. The funds are intended for the future transfer and restoration of the Alvarado House once a permanent home for it has been identified.

Explanatory Notes

1) Significant Accounting Policies

(a) Method of Accounting

The financial statements have been prepared on the accrual basis of accounting.

(b) Basis of Presentation

The Foundation follows the provision of Statement of Financial Accounting Standards (“SFAS”) No. 117, Financial Statements of Not-for-Profit Organizations. SFAS No. 117 requires that net assets, revenue, gains, expenses, and losses be classified as unrestricted, temporarily restricted, and permanently restricted.

A summary of the net asset categories included in the accompanying financial statements is as follows:

Unrestricted – Unrestricted net assets included amounts that are available for support of the Foundation's operational and administrative functions and amounts that are available to support community activities and charitable endeavors at the discretion of the Foundation's Board of Directors.

Temporarily Restricted – Temporarily restricted amounts represent funds, the principal of which may be expended in the future for a specific purpose (e.g. the Lagoon Endowment Fund) and contributions receivable that upon receipt will be transferred to unrestricted funds.

Permanently Restricted – Permanently restricted net assets represent those assets contributed to the foundation where the original dollar value is to remain in perpetuity as a permanent endowment of the Foundation.

(c) Investments

Investments consist of marketable securities. Marketable securities consist of U.S. government securities and debt and equity securities. Equity securities with readily determinable values and all debt securities are carried at fair value. Fair value is determined by quoted market prices on the last business day of the year.

Investments acquired by gift are recorded at their fair market value at the date of the gift. The Foundation's policy is to liquidate all gifts of investments immediately upon receipt.

(d) Pledges Receivable

Pledges receivable reflect the present value of the future receipt, discounted at a rate of 5% per annum as of December 31, 2014.
